I. CALL TO ORDER

Commission Chair Gustafson called the meeting to order and led in the Pledge of Allegiance.

IV. CONSENT AGENDA

May 2023 Minutes and Monthly bills were presented at the meeting – no further discussion

MOTION: Dresel
SECOND: Chartrand

Discussion: Chartrand stated there was a typo in the bills as presented. The ACH (Automated Clearing House) for weekly payroll have incorrect comments on their lines, showing “oil change” and “Chief’s Conference”. Both comments will be removed from the bill’s list.

V. BUSINESS ITEMS

1. 2024 Police Commission Budget

Chief Schlumbohm presented the annual budget for 2024. Several increases were noted due to insurance cost (Health, property, worker’s comp, and auto insurance) increases as well as salary increases.

MOTION: Gustafson
SECOND: Chartrand

DISCUSSION: Commissioner Chartrand asked if the 25% the cities pay for the School Resource Officers is due to the school's inability to pay the full amount. Chief Schlumbohm advised that the control only calls for the School District to pay for 75%, as they only utilized them for 75% of the year, and the remaining time they are working for the cities.

Commissioner Dresel asked if there was money in the budget for a lobbyist. Chief Schlumbohm advised that based on feedback from Commission and Council members, money was not put in for a lobbyist for 2024. Commissioner Dresel advised that he would like to open that item for discussion and is aware that the lobbyist is later in the agenda.

MOTION: DRESEL SUSPEND AND MOVE TO THE NEXT AGENDA ITEM
SECOND: CHARTAND
MOTION PASSED UNANIMOUSLY

2. Police Building Update

Chief Schlumbohm advised that the Lindstrom Council met as part of their overall budgeting process for their 10 year vision and setting of priorities. Their contributions to the funding of a new building were part of those discussions.

Lindstrom Administrator Udem was invited to provide an overview of the discussions to the Commission. He advised that they discussed how the funding of the building fits into the city's future budget, and what the financial impact would be. The 10 year plan should be coming back in August and should provide some good insight in to how those costs would fit in. There were also some comments by Lindstrom Councilmembers as to how those costs were distributed, and does the funding mechanism for the building being a 50/50 split make sense. There were also some concerns expressed by a councilmember about increased response times to the schools (High School and Middle School) if the new building were located outside the city of Lindstrom. A Lindstrom Councilmember also expressed concerns that there might be an existing building that could be retrofitted to serve as a police department. The councilmember suggested one option would be to remove all the existing city staff from Lindstrom City Hall, and turning that into a Police Department. Finally, a Lindstrom Councilmember wanted to make sure that the citizens of Lindstrom were supportive of building a new police department, and take the temperature of citizens.

Commission Chair Gustafson advised that those same issues could be applied to Chisago City as well, and stated that the existing building was situated at the farthest point east in the entire district, and would like to see the location more centrally located.

Commissioner Dresel stated that his concern is that this issue is ripping apart 8 years of work, and we need to restart the process putting it 5-10 years down the road. He stated he would like to see this continue to move forward as opposed to starting over. The work over the years includes multiple years of efforts by a lobbyist, State Senate tours, State Bonding tours, staff time, getting on the Governors' s bonding list, and would be greatly disappointed to see all that work go to waste.

Chief Schlumbohm asked if there was a timeline on Lindstrom's 10 year study.

Administrator Udem stated his understanding is it will be August, and the Police building funds will be in this plan, but advised he was just starting with his position with the City of Lindstrom in the last week, so there is more to understand.

Commissioner Dresel stated that brings him back to his concern about not having a lobbyist in the budget. If the issues are not pressed, and kept in from of the Senate and Representatives, do we lose the gains we made in the last few years. He stated it is important to keep them in the forefront at the state level.

Commissioner Chartrand asked when does all of this take place. Chief Schlumbohm stated the State bonding piece has already started, and the preliminary budget for the building has already been resubmitted to the State for the 2023-2024 legislative session. He advised that the budget is submitted to the Office of Minnesota Management and Budget (MMB), which then forwards the information to the Governor for his consideration. The Governor's list is then submitted to the bonding committees for review and forwarded to the Senate and House.

Commissioner Chartrand asked when the bonding tours take place. Administrator advised that it was around October. Commissioner Dresel advised that it appears that the building is still in the consideration, so do we need to secure the services of the lobbyist again. Commissioner Chartrand stated that it appears that the lobbyist was doing her job, but what is the ROI on it? Chief Schlumbohm stated that it costs each city about \$5000 per year for a 3 million dollar return. He also stated that there is no one in house that has the expertise to work with the State legislature, so the lobbyist's expertise and abilities is essential. Commissioner Chartrand stated that it was unanimous from the Lindstrom perspective.

Commissioner Norelius stated that no one on the Lindstrom Council understands exactly how Lindstrom got into the position. Without having their ducks in a row, and understanding why all of these scenarios have happened the particular way they have, they don't have people who are behind it.

Commission Dresel stated that he understood that, but the point is that the Commission would be throwing away years of labor with the lobbyist. He stated that you can put the money in the budget, but you don't have to spend it. But if it is not approved tonight, we are out of the game.

Commissioner Chartrand stated that she did not want to throw in the towel on the project, but finds it hard to believe that the only way to get it accomplished is through a lobbyist.

Commissioner Dresel stated that you don't have to use a lobbyist, but you will increase the costs of the project by 30%, because you won't get state participation. Then you will have to shrink the project, and start the entire process over again.

Commissioner Norelius stated he would like to know what decisions were made based on what. The study that was done by BKV focused on a building in Chisago. Everything that I've understood I don't...Nobody can answer can answer what the expenses are going to be. What's the... How are we going to pay for this thing? How is Lindstrom going to pay for it? Dan comes in and says you know what, our financials don't look that great. So if somebody wants to share with me, and we can walk through this process, we can have a special meeting, you know, us, to hack through why certain decisions were made, why and how fairly those were distributed through the two cities then you know, I might be better, get behind it. You talk about the years that have been put into it, talk to Mayor Carlson. There was one...I think...Your father coming with a proposal some time, years ago, and that was looked at, but not moved forward with anything, you know, and then he said we didn't talk about it. It wasn't a thing. So...I understand that we had a good push in the last number of year, but I still don't understand the

business decisions behind it. The size of it. The cost of it. Why can't we do a six million dollar building? We talk about a training facility, they won't let us have training over at the Chisago, or the County because of liability. Well, how can we all of a sudden take on the liability at this facility. Why haven't we invested in the...our police department here, over the years. You know? We haven't spent any money here. You guys haven't said, Hey we need to fix up this place over here. Absolutely not put a dime into this place for all these years. Now all of a sudden we're just gonna go from rags to riches...I'd like to know how we got there, and why the decisions that have been made, have been made. I understand what you're saying, I totally feel the pressure, I feel what you're saying, I don't want to step on peoples efforts and energy and time, for sure, but somebody has to be clear and concise in what...and have a...It's got to work both ways and it feels right now that it's all...slid your way...and for me....that's where I'm at.

Commissioner Dresel stated If that's what you guys want to do, that's fine. But now it pushes it 5-10 years down the road. It's not going to happen quick. Now we have to go through all the discussions and negotiations, and this, and we meet every two months. I don't think Chisago is going to have a lot of appetite to go through this whole thing again.

Commission Chair Gustafson stated it's been two or three years we've been going through this with Lindstrom, and all of a sudden it got hung up. So I don't know really where we are at. What's holding up the process, or whatever, I thought we had this party down the road.

Commissioner Norelius stated Well, we had a bunch of yes's from...without a lot of consideration for other things, is what I feel. So, I'm sorry we got new people, and people that are interested in making the best decisions for our community. I need to get better up to speed, the Council needs to get better up to speed, I'm not the only one. So we had unanimous feeling on this, and I think the pressure is high for sure, but what is it? What...If we are this far along in understanding we need a new facility, is there room and space in the next 2-3 months to reevaluate things...Whatever, size, cost, location, all of those things and we run through those parameters and we come to some sort of a new together decision. That's what I'd like to see.

Commission Chair Gustafson asked, I thought that Lindstrom was going to have a special meeting just for this.

Commissioner Chartrand stated, We did.

Commission Chair Gustafson asked, Didn't you discuss that stuff?

Commissioner Chartrand stated One of the things that came out was, How much can we afford? So we are getting a financial management so we can figure out, can we afford one million, two million, three million? Questions were asked about on going operational....several Councilmembers asked what's the ongoing operational costs to maintain the building? What's it going to cost us? That's what we'll come here and get answers to that question.

Commission Chair Gustafson stated Well, we won't have the answers here.

Commissioner Chartrand stated We should have some projections.

Commissioner Norelius stated There's got to be projections. Yeah, I mean... I assume you are going to....I mean maybe...But it seems...Just kinda of blindly just going in. Just because we want this building...it's like...everything just thrown out the window...We're just gonna go for it.

Commissioner Chartrand stated So, we are looking for projections for operations. You know, we should be able to ballpark, and get information from Excel Energy on heating, cooling, all of those things. The other questions that came up is if we have factored in inflation, was the nine million from two years ago? If there is inflation, we should probably do a factor in there to see, are we up to ten million now? Where are we at?

Chief Schlumbohm advised that with the new submission, inflation was factored it, and added to the State contribution.

Commissioner Chartrand asked, So are we at a max of nine?

Chief Schlumbohm stated “We did a 10% inflationary figure, so we went from a 3 million state contribution, to a 3.3 million contribution, to a 3.6 million State contribution.

Commissioner Chartrand asked, so we’re asking the state to pick up all that?

Chief Schlumbohm stated, yes.

Commissioner Chartrand responded, Nice. I like that. That is really good. So Bob, those are some of the things that came out in that discussion. The tax capacity came out again in the work session. We have a contract, the contract runs till 2030, and that’s fine. But it came up when building the building, should we be going 50%/50% split, should we be going tax capacity.. With some of our councilmembers clearly favoring tax capacity.

Commission Chair Gustafson asked, so that was your council?

Commissioner Chartrand stated, Yes, at the work session. I’m just telling you all the things that came out at the work session.

Commission Chair Gustafson stated, Well I know that Chisago City will not be in favor of tilting this thing one way or another. To Lindstrom, or to Chisago. It’s always been a 50/50 deal, and someone is going to have to prove to me that, that is unworkable. That was the way we were going to do it as I understood it.

Commissioner Norelius stated, Obviously you guys have....Things have changed, right? You guys have taken on a whole nother land mass, the Highway 8 project coming through.

Commission Chair Gustafson stated, Well, we’re not going to penalized for something that Chisago.....

Commissioner Norelius stated, Well no, you pay your fair share. You pay your fair share.

Commission Chair Gustafson stated, No, it’s a 50/50 deal, and that’s....

Commissioner Norelius stated, Well, that’s crazy.

Commissioner Dresel stated, So what I’m hearing is that there is no appetite to do anything with a lobbyist for the next year.

Commission Chair Gustafson stated, Yeah, it sounds like it.

Commissioner Dresel stated, That's what I hear.

Commissioner Chartrand stated, You're asking me, coming out of the work session, so.... The only way that if we put it in, we just need to be able to pull it right back out.The biggest thing we need to know, we need to get that feedback from Abdo. And we did ask, in all good conscious, we said 3, right? I mean, that's what we popped in, in terms of the planning.

Administrator Udem said, I assume that's what's popped in. I don't know, I'm just getting on board. Can I offer a suggestion?

Commission Chair Gustafson said, Go ahead.

Administrator Udem said, On the lobbyist side, it's something you put in the budget for 24, if the lobbyist doesn't go through, those dollars are there, so if it comes through and the building is built, that sits there and builds fund balance, so you're starting to build in those operational expenses in the budget, so you are starting to bake some of those costs into the budget. If this thing goes totally off the rails, it can come off at that point. But right now, at least you don't have to go back and amend the budget. Then if you decide after it goes through the whole analysis, the lobbyist is good, then the dollars are there.

Commissioner Norelius stated, I agree.

Commissioner Chartrand stated, I agree with that.

Commissioner Dresel stated, That was my point. If we put it in there, if there's a zero chance, then lets not put it in there. But if there is any pathway that we think we're going to go with a lobbyist, then let's put it in there. And I just got the sense that there's zero pathway.

Commissioner Norelius stated, I don't think there's zero pathway, but it's being realistic about what is fair, and how things are changing with our two communities. And it's changing drastically. And it is going to be different in 10 years here. So, umm... When you've got that kind of land mass, and you've got what Lindstrom is locked into, it is, it's very much different. So I don't think we can get locked in a box if this is the only way it's going to be. But we need to look at what the future is going to bring, and how that looks down the road. And it may change and be different from what it is today. I don't know if there is still room within the process that we have, to say alright, can we say that we...we're gonna go back to the county and use their training facility and not have a training facility in this police building and knock it down to 5 or 6 million dollar project. Is that possible at the point we are, or are we so locked into this list of things that you cannot veer or steer anywhere different?

Chief Schlumbohm stated, I don't know what you are envisioning for a 3 million dollar training facility, but that is not in there. You take the training facility out, you're talking a couple 10s of thousand of dollars. It's just a room.

Commissioner Norelius stated, Oh, ok.

Chief Schlumbohm stated, I'm not sure where that is coming from.

Commissioner Norelius stated, I'm just saying we've got a five million dollar fire building over here, and I'm just wondering...nine million dollars...I'm not familiar with why it is so much more expensive for that particular building.

Chief Schlumbohm stated, Well, that's just a garage.....

Commissioner Norelius stated, Right. Yeah. You're talking about finishes and all of that. Yup.

Chief Schlumbohm stated, Computer equipment, desks, lot of walls.....

Commissioner Dresel stated, Irrigations systems, more spaces....

Commissioner Norelius stated, Yeah, more finished spaces.

Commissioner Chartrand stated, So that was one of the requests that came out of the work session, if we find we can't bite off the 3 million plus operational costs, etc.. What if we did have to cut it back, where would we cut it, and I had that conversation with you, I think you're the one who knows if we have to tighten our belt financially, you would know where those....

Chief Schlumbohm responded, It's real simple. Our backup plan is to eliminate the garage, we may just have to have a small sally port and leave space where we can build a garage in the future. It's important to protect that equipment, everything we leave sitting out there rotting, it costs us money. That's the reason the fire department puts its stuff inside, but if we have to do something, in the hierarchy of it, the garage is the one to go. That's where we would save our money. If we have to. But honestly, I can't keep having these guys doing the drug testing on fentanyl on their lunch slash board table..interview room....

Commissioner Chartrand stated, I agree with that.

Chief Schlumbohm stated, It doesn't make any sense.

Commissioner Chartrand stated, I agree with that 100 percent. I want to clarify, we did talk about retro, but not quite...I think they were talking about the old fire station as potentially retro, but what I did bring up, and I just want to bring it up again. We don't know we are going to get bonding in the spring. We're sitting here. We've sat here for a couple of years, and these guys are crowded, and they are doing things that are probably out of compliance because we didn't give them enough room to do what they needed to do right. So my comment was, could we as a stop gap, short term solution, use this space because it is already here, and move our staff, the administrative staff out to..... I mentioned Scottsdale mall, but obviously out to a different location for a couple two or three years until we get a building built. Because we don't have a solution today. I don't know that there is a guarantee that Koran is going to that for us in the spring. And then it's going to take two years to build that. So I did propose a short term, but it was not meant to be a retrofit, it was meant to be a stop-gap measure while we figure out our longer term.

Commissioner Norelius asked, Is that something that Chisago would invest in, a million dollars here? If we need to?

Commissioner Dresel stated, I don't know. I guess we'd have to look at it and see what...

Commissioner Chartrand stated, What would it be? I think we need to anticipate a stop gap measure, because I was surprised by Anne Nue Brindley's response in the spring. It wasn't what I was expecting. We don't know what we are going to get in the spring. That is why I'm a little sour on the lobbyist. I mean it's like, how did we not see that one coming? We didn't see it coming, and I about fell off my chair when she spoke against it, the way she spoke against it.

Chief Schlumbohm stated, What I have learned from the lobbyist, is that the House is not where it is at. They are not the ones who control the purse strings. At least the republican side, and if you want something done, the only place there is a hold on them is on the senate side. They have a key group of senators there that have to vote with the democrats to get the bonding passed. They cannot do it without them, and so they court that side. So while Anne spoke also spoke publicly against both our project and Highway 8, Senator Koran, if you look at some of his public comments, also did not verbally support Highway 8, but in speaking to him and the lobbyist, he was the one who made sure it got through. There are other things that happen, that don't go on television.

Commissioner Chartrand stated, So if that is the case, that goes back to my point. He is our key player here.

Chief Schlumbohm stated, He is our key player, and he is the one who has been working with our lobbyist, keeping it in front of his face. It has not been us. We met with him twice.

Commissioner Chartrand stated, Correct. So he's aware. I don't mean to take it off topic, but I did want to clarify that stop gap measure, because I think it still should be a discussion item here, either we think it's a good idea or your don't, but you guys deserve something better tomorrow, not three years from now.

Chief Schlumbohm responded, That would be great.

Commission Chair Gustafson addressed Administrator Pechman, John do you have any comments to make?

Administrator Pechman stated, it sounds like Lindstrom has a lot of work to do. They have to move, figure out what it will cost to renovate this, figure out how Chisago is going to pay a million dollars a two year fix....

Commissioner Norelius stated, Well, I don't know about two years... I know she said two, but....

Administrator Pechman said, Well, it sounds like you guys aren't even on the same page....

Commissioner Chartrand said, Well John, how long does it take to do a building?

Administrator Pechman, I don't think you're wrong in anything you're saying, but you say tomorrow, but none of this is going to happen tomorrow. None of this is going to happen in a year. If we go after this (renovation) project, the same way you've gone after this project that we have currently, it's never going to happen. We might as well pitch it, and just have them stay there.

Commissioner Norelius stated, No, I don't agree at all. I don't agree at all John.

Administrator Pechman said, Well, you're 50/50 partners, whether you like it or not and you have to get both sides to agree. So if you're going to treat someone a certain way, and then come back and says let's redo all this, and that's fine, you can. But don't expect us to say wait a minute. Hold on. We want to see this, and we want to see this, who decided this, when did this happen, who talked about this, it's not gonna happen. In the meantime, we just spent 20 grand of our money thinking we had a good faith effort from you guys. That doesn't go left unnoticed.

Commissioner Norelius stated, Not my issue though.

Administrator Pechman responded, It is your issue. You're sitting there now and you are part of it, so it is your issue.

Commissioner Norelius said, Yeah....

Administrator Pechman continued, So mean, there's all sorts of other things, it's just not going to be this golden parachute any more, and it shouldn't have been, to your point. I'm not saying it should have. But it was going swimmingly, right or wrong, however your perspective was or what you know and now it is just Bam, done. So we have to deal with that first, and then decide if whatever....It doesn't even sound like the agreement is any good anymore, so why are we doing any of this?

Commissioner Dresel said, 5-10 years, back to my point. 5-10 years before we even think about a building. That's what we are throwing. So, for 20 grand, we are throwing 5-10 years.

Commissioner Norelius stated, We're not talking about 20 grand right now, we're putting that in the budget.

Commissioner Chartrand said, We talked about that, we're putting that back in the budget. Your point was, don't take it out.

Commissioner Norelius responded, Yeah.

Commissioner Chartrand said, Right? So we've still got that. So we're talking.... Are we ready tonight to commit to three million dollars? I'm not, until I see where the finances are.

Commissioner Dresel stated, And I don't disagree with that at all. If you guys can't afford it, you can't afford it, that's just the facts.

Commission Chair Gustafson said, Yeah, we can't do it alone.

Commissioner Dresel continued, But by not having it in the budget... I don't know if we missed the point, right? If we don't have it in the budget, which why I did what I did. We threw it away. Right? If we can keep it in the budget, it at least keeps the conversation going. If we take it out of the budget, the conversation is done.

Administrator Udem said, I think I would also say, too, again...new guy in the room here... It seems like Chisago has already had a long time on this project but there is a lot of new membership on the Lindstrom side, that probably is not as comfortable...just needs to get comfortable with the decision to make sure, because obviously both cities are making their own votes on this, so it's sort of like...Let us get up to speed.. I understand it's frustration on your side, it's like, hey there's new guys in the room, we need to start over from scratch. From Lindstrom's standpoint, we just have to make sure this is the right decision because the taxpayers of Lindstrom are paying their portion of it, and we just need to make sure that it's the right building, and the right fit, and everybody is comfortable with the decision. I just ask you to let us get up to speed, and sort of reevaluate that to make sure it is right, because those are previous agreements, those decision makers aren't the one making the decision now. So it's a full new set of eyes on this, which I don't think a new set of eyes on this is the worst thing in the world, just to make sure like...I look at the budget here, and there aren't any items for electrical use, and that's a new expense that's going to come online with the new building. So again, let's take a look at everything so we know what we're going in, eyes wide open vs assuming we'll deal with it down the road. I'd rather go in eyes

wide open, we're just re-doing our due diligence which I think in a partnership, if one of the partners wants to go back and reevaluate.... It's not going to take us years to get this done.

Commission Chair Gustafson stated, I can understand that to a point, but the point of it is, we've had this discussion going on for how long? I mean, we can't all of a sudden just say... Well, one of us hasn't thought about it that much, or paying attention to what's going on for so long... I'm just trying to say, how do we ever go forward?

Commissioner Norelius responded, I think if the talking points are all lined up, and we're in alignment, I think we can go forward, and I don't think we're irrational or unintelligent people, I think we can get it, but you can't go into this thing with the space, the size. Where you guys are going, it's a different direction than Lindstrom, and my taxpayers shouldn't pay more for Lindstrom policing individually, per household, than your people. Because with 26 miles...

Commission Chair Gustafson said, You shouldn't.

Commissioner Norelius stated, No what I'm saying is that the 50/50 deal doesn't work, and if we can't look at what's going on, for an agreement at 2030, we need to look at all of those things. If we agree that this is a great long term thing for us to spend 9-10 million dollars over there, and us to spend 3 million dollars over there, and that is totally fair, I just want to flush out the agreement, and it's coming up in 2030, and you know, how long is this going to take us to pay it off? We need to work through those details, and some of those things could change. The way we handle it could change.

Commissioner Chartrand then said, I think it's important to be clear, we opened the work session, I want to reiterate it here, We have a terrific police department, it's working well. When I was up at Duluth, and I know you had some of the same conversations, we talk to cities who were doing joint fire, joint police, even though some of them said it gets a little frustrating at times, they recommended to us that it is the right way to go, it is the most financially efficient way to go, so I know you're not hearing all those positives, and maybe that's on my to articulate those positives to you. But please do respect that we have faced a lot of projects over the 6 months that we have really had to dig into our finances and look at more carefully. So if we're coming in with a little bit of suspicion, you know, it's not animosity towards you in way shape or form.

Commissioner Norelius added, I agree.

Chief Schlumbohm stated, Well our next meeting is in September, we should have something back by then, right?

Administrator Udem said, As far as I know, and again, I started on Tuesday. I'm going to do a hard press to get it back in August so we can have this discussion. I'm going to hold their feet to the fire, if we're paying them, we're going to hit a deliverable. I just don't know where they are on the project.

Chief Schlumbohm said, So I think that at least Lindstrom will be able to come back with more information, once they get their 10 year plan put together, to give them a much longer view as to where they are going to be.

Commission Chair Gustafson asked Administrator Pechman, John, what about Chisago City, where are you at?

Administrator Pechman, stated well, it will be in August. The vote on the budget is today, so it sounds like we are putting the lobbyist back in. My question is, if we are going to do cost analysis, not that we shouldn't, that all costs money, and we don't have the people to do it. So I'm assuming that's all falling back on Lindstrom, and you're all going to do that on your end, to figure out what the costs are for the building? Some of the unanswered questions you have?

Administrator Udem stated, We're putting in....our cost estimates are using what is existing out there. We're just basically saying, Lindstrom's share...I believe the estimate was 3 million, that's the number we put in....obviously in the 10 year plan we'll have to see if we have to adjust that slightly up or down.

Administrator Pechman stated, You're talking about the capital side, I'm talking about the operational side. Those operational questions, those keep coming up. It's important to you, I've heard them every time we've talked, somebody has to do that. It's not going to be me.

Administrator Udem stated, Well, we can use a rough number. We can find an existing building, and base the costs of utilities on that.

Administrator Pechman stated, Yes, but we need to see who is doing what. I think we need to get to a point. Chisago, here's these questions, but no one is doing anything about that.

Commissioner Chartrand stated, And that's fair.

Administrator Udem said, Basically from an operational standpoint, is it 50 grand a year, is it 100 grand a year to operate, I don't know. I'm coming from previous building where all of them were combined into one. To find a similar building in the area, that's the starting point. Obviously we'll shift up or down, based on what is there, but plugging those numbers into the operational side, so we'll know the debt service is going to be x amount per year, and the operational budget when that building comes online it'll have to go up to Y to cover those operational expenses. Otherwise it'll be taking on debt service in year 26 and suddenly operational expenses in 27, and those are all dollars that are coming from both sides. So again, at least it is a starting point. I'm not saying it has to be perfect, we can find tune those numbers further down the road. We'll figure out a number based on reality, it's not just me pulling a number out of the hat. I'm assuming we have some building somewhere in the system that we can at least look at what the operational costs are.

Commissioner Norelius stated, I mean is Chisago....It doesn't matter to them what it costs, operationally? I mean, I'm just wondering, is that a non-issue?

Administrator Pechman responded, That is not true. We know there is an expense related to that, and we'll know roughly. To the same point, It's fairly easy to find out.

Commissioner Norelius then retorted, So you guys have that information already?

Administrator Pechman responded, No, but we have other buildings that we would base it off of.

Commissioner Norelius than said, Well, I didn't know if you had analysis already done.

Administrator Pechman stated, Well, he's (Udem) talking rough estimate, and you're talking analysis. I'm saying, who's checking these boxes off?

Administrator Udem stated, So again, I think the direction I got from the work session was, At least let's prepare the budget because right now, with this budget, operating a building is not envisioned in this budget, because there's no expenses now. Chisago needs to budget for their portion, their not charging back, and Lindstrom is not charging back, as far as I can read through here. If I'm wrong, correct me.

Commissioner Norelius stated, No, correct.

Administrator Udem continued, But if you look at a new building that's owned by LAPD, you have to get those costs in there, so at least plug a number in there. I'm not talking a detailed analysis with month to month costs, electrical is \$550 a month...heats going to be a thousand bucks... Does 50 thousand cover it.. I don't know. It might be lower, it might be higher, but it starts at a point. But when the building comes online, we know what those operations costs might be. We don't have to expend that money until the building is occupied.

Commission Chair Gustafson then asked Administrator Udem, Can you and John get together somehow? John, work through this? I know there's got to be a lot of questions, you know?

Administrator Pechman stated, To your point, maybe you're getting frustrated too, because it's like we have the same questions and it doesn't seem like we're getting answers. You kind of get to the point of who's doing what?

Commissioner Norelius said, I get that. I feel like if we could meet easier... It's just part of the government thing right? I'm a business guy, I pull the right people in the office, we go and have a meeting, and we get it worked out, right? You know? So, it's a little harder in this situation to really find out, who's going to take this, who's going to run with this, I know there's costs. So...We're working through those dynamics.

Administrator Pechman then said, I think my point to, do we need more money in our police budget to look at these questions? Or is this something that is going to be handled outside the LAPD going forward? A lot of this is to decided just getting answers to these questions.

Commissioner Norelius said, Don't you think we can expense some resources, Dan? Some resources internally?

Commissioner Chartrand said, Well, we have to ask Dan.

Administrator Udem stated, Well my two cents on this is, in going through some project designs in the past, if the Commission is comfortable with ball park operational numbers, we don't need to expend resources doing a full operational analysis, understanding the caveat that those numbers could fluctuate based on the reality that is there. But as long as you're throwing a number against the wall, that's based on some semblance of fact, you know, an existing building with a similar footprint. Even if we took just the operations costs of this building here, it's probably inefficient, but it could be a worst case scenario. If we're fine with that, then I don't think we need to do a full analysis. If the Commission really needs a deep dive on what those costs are, then to John's point, I think we need to get a specialist in here. I think we can get by with a placeholder number that staff can do based on existing buildings.

Commission Chair Gustafson said, I would be very comfortable to know that you and John can get together and compare notes. I'm sure John's got to have questions. You guys have to have questions, I know I do, for sure. I don't think we're on any kind of a roadblock here, you know?

Chief Schlumbohm said, I think as long as you have good expectations. If you're talking about a study, yes we need to hire someone, because no one here is qualified to do that. If you're talking about some general cost estimates, and I use the word estimate very specifically, that is something that is do-able. Honestly, I keep hammering this over and over again, keep it simple. Keep it 10,000 foot. If you get too far down into the details, not only can you get it wrong, you'll get frustrated and angry. If you want to talk about costs like snow plowing, and honestly, I'm not going to speak for Chisago City, but if it is adjacent to Chisago public works, I'd be willing to bet a good amount of money that they'd plow us out just like the fire department, for free. I'm pretty sure a lot of that, including the grass cutting and such as well. There's a lot of these costs that are built or baked in. If you want to drill down to – you owe me five dollars for four minutes I did something.... It's just dumb. It's the opposite of the reason we got into this. We got into this to keep it simple, share resources and be able to take a bigger resource and push it at smaller problems. So we put all these resources together, so we can have a giant resource to tackle bigger things. If we start breaking it apart again, we might as well not have combined it in the first place, because it doesn't make sense.

Commissioner Norelis stated, I would agree and I totally understand that comment, but we're looking at spending 3 million dollars and we haven't been able to reside the building here, right? I mean our priorities have been different in the past. We haven't been able to afford.... Like I said, go take a look at the siding on this building, and we're talking about doing that and our expenses go up by the month, by thousands of dollars and we can't take care of our own building, and we've got a problem. So I mean, that's what we're looking at here, that's what we're trying to figure out. Trying to be....as astute to all of the things that are coming at us that are affecting us, and we are trying to make sure we got the right decision made here and..like Judy said, the Police Department here is doing an awesome job, I hear zero complaint from anybody about it. I guess the other question I've got is within this budget, should we be putting anything for improvements here to get you by for the next year....or two?

Chief Schlumbohm responded, I don't know that without massive reconfiguration to this building, we'd be able to accomplish even some of the minor things we need to have happen. I mean the biggest thing is, how do you move your storage facility...How do you move the Police Department from in between the storage facility for city hall, and city hall? How do you make a secure area where you are testing drugs, that has it's own ventilation system?

Commissioner Norelius stated, There's options. There's options. But that's the questions I've got for this commission. Should we put in some money in the budget to make improvements here for the police for the next two years. Even if you're going to build a building and it's coming out, you've still got to live with this for two years. Your talking about... We bought our table from K-bid or whatever. Like we can't do more to make what we've got better? I guess that's my whole point, rags to riches, that doesn't add up for what we've done for them for the last 10 years and... It sounds logical to me to put some money in the budget to at least give you something to make this better back here in the next two years. That's my two cents.

Commissioner Chartrand then said, And I'd like to see, as a discussion point... Bill, just think about it, I mean obviously we weren't going to go down on our own work session and you know, say hey this is going to solve problems, let's do this. It was floated, and it's coming here. Do we need to have something, and I was thinking probably three years because bonding is not going happen till next spring, and then two years to build. That's what I was anticipating. That's a long time for you guys to be doing stuff that....

Chief Schlumbohm replied, It is, but I don't know that adding two million dollars to this building is helpful either, for bonding or anything.

Commissioner Norelius said, No, We're not talking about that. I just threw that out there. Don't take it literally.

Commissioner Chartrand then said, Just be thinking about if there is space, if we move the administrative staff, is that going to solve problems. If it doesn't solve any problems, that's not going to be the..... It's just an idea. That's all...and no, you can't have this space.

Chief Schlumbohm said, The thought was..if we can get the police....and I've spoken with the previous administrator about this, if you can get the police out of this building, you've got ample room for your own expansion, we get out of the public work building, then they don't need another building, we are trying to create space, not take over more...and then we aren't taking Big Scottdale mall off the tax rolls, making it untaxable.

Commissioner Chartrand replied, That's the point. My point is....3 years. You're going to be back there for three years...and I get you. I'm with you on the future plan, 100 percent. But for the next three years...you can't building any faster than humanly possible.

Administrator Udem asked, Can I was the Commission a question? With that, to the point of improvements to the existing facility, is that something...If we put something into the budget, when the new building gets constructed, those dollars can go into maintenance dollars for the new building so we don't get behind on maintenance. I've seen a lot of times when buildings get built, and nothing gets put aside for maintenance, because everything is brand new. You move into the building and your first 10 years is the honeymoon because everything works. But by year 13, everything starts to break and you didn't put any capital away and you've got nothing to go back on. So if you start putting in maintenance into the budget now, that might be a stop gap, you might have some dollars to take care of some small projects in the existing facilities that LAPD occupies. So again, move forward those dollars can just transfer into the new building so you automatically start prefilling your maintenance fund for that new building, so that you don't in 10 years needing to be like...Oh....whatever broke needs to be fixed. I came from a building that was brand new, we're at the point where that building is like year 9 or 10...stuff is starting to age out and needing replacement, and we needed capital. Again, it's just a thought. It pre-fills the budget, prepares the budget for it.

Commission Chair Gustafson asked, John any comments?

Administrator Pechman responded, No, other than to Brian's point, I don't know any of the specifics or costs of what we are talking about, so it's hard to throw money at the wall for all of our taxpayers. It doesn't make a whole lot of sense. Maybe a year from now it'll be a little more clear, the next budget cycle might be a little more clear. What you guys have in mind that we might do, or might work. Where you are going to put it, or whatever.

Commissioner Chartrand stated, What would be helpful Bill, is if you could just say... Here's what would get us in compliance. Make us a little more comfortable, but maybe number one...You know the space that we've got. That we're working with, and if it's not going to work, it's not going to work. It won't take long to figure out how much it's going to cost to rent the space. That's not the issue. The issue is, what do you need, and here's what we've got, can it be done...and I'm going to be blunt, can it be done cheaply.

Chief Schlumbohm said, How to rebuild this building and make it compliant.

Commissioner Chartrand replied, Yeah. Because you were saying, it was the issues, I mean some of the things you bring up is...I mean...yeah. You're walking people right in here, but it we're not there, then you've got control over the entire...you know, outer ring here of this building. I'm not the expert, but I know that there were some issues that were pretty uncomfortable for the way we are handling stuff.

Commission Chair Gustafson then asked, So what suggestions do you have? That we haven't talked about.

Chief Schlumbohm responded, In the past, I have through two buildings looking at refurbishing options, with the Police Commission, with Councilmembers.. The costs for refurbishments to make those buildings usable can be substantial, and in the end you're still ending up with an older building. You still have the core, and the guts, and the refrigeration units and such that are just older. We looked at the old hospital, and I tell you what, you take one look at the 1960's boilers that they have in there, we'd have to have a boiler technician on staff. We looked at the Plastics Products building when it was Smith Metal. We toured that facility. That was a nice big open floor plan, but again it didn't have anything inside for offices, but we looked at it. We looked at it very seriously. We went through that. We looked at attaching a new building to both fire halls. We've done a ton of various scenarios. This would not be the first or the tenth time. I'm not saying, let's not do that, I'm saying that we have some experience at looking at that, and we know some of the pitfalls, and some of the problems with that. It can be expensive. A holding room alone, you're talking cement blocks that are core filled with concrete and built to DOC specifications, whether it's going to be a new or refurbished area. Those things come with costs. It's where you choose to use your money. I have a daughter, and she had a car, and I had choice like I can keep fixing up the car, and make it go a little longer, or you can say enough is enough, and you find something else. It's a decision, something you have to look at.

Commissioner Chartrand said, I just want to be clear, I'm am not suggesting retroing this for long term. Not at all. Not at all. But I also worked in organizations where your working out of compliance, you doing something, it's hard on morale, and it's just not a good practice. So is there any way, and I do mean cheap, and I do mean short term, is there something that we can do for you, and if the answer is no, then that's fine. I just want to put it on the table.

Chief Schlumbohm responded, My suggestion...the only thing I can think of, and I've thought about this quite bit, in this building would be to take all of your record storage area in the back, and vacate it. Put that towards the police department, and you can take all of your records and all of those things...and believe me, the staff go back there...not weekly, but several times a day..and find some placed else to shoehorn those files in this building, and you'd also have to have your public works director vacate his office, and we'd have to put a secure door up to that area. That would address one of our non-compliant issues.

Commissioner Chartrand stated, That's what I want to hear. Yeah. And we don't need to do all that tonight, but that's helpful. Because I would think you guys see we're paying attention here, and I want to send a message that we're not, not going to build a new building because I did not hear that anywhere.

Chief Schlumbohm stated, No, I think 100% both councils agree we need to do something...Just what?

Commissioner Chartrand stated, Short term, and then we need a long term.

Commissioner Dresel said, And I think that is what we talked about at the last meetings. You guys have a new council. You guys have lots of questions. We feel like we've already been through all this. You

guys just need to get up to speed, and you guys have to define what issues you have, and work through those issues. That's three to five years.

Commissioner Chartrand said, You know, I think...

Commissioner Dresel stated, If we abandon this, that's three to five years.

Commissioner Chartrand said, You know, the big piece, because we're representing five, you're seeing two here...I do think the financial will provide a great deal of insight for the Lindstrom City Council. I'm just...to be pretty public about it, we did a road maintenance plan..to do it up right, to do it full across a number of years, we're talking a hundred million, I don't remember if it was 20 years or 30, but it bogged my mind. We asked the engineer, we're in the lower 25th percentile on our roads. We've got 5.5 million sitting right next door and that's going to hit us right now. We've got some other things I don't want to go into, but we've got.....It's all financial. It's all financial, and that's not getting up to speed, that's being up to speed and we need to be really thoughtful here, and I don't want to send the message across Lindstrom that we're having finance problems, because that's not true. But I do think we need to be very thoughtful right now.

Commission Chair Gustafson then said, Ok, where are we going from here?

Chief Schlumbohm stated, This was just discussion, so we don't need a motion here, so we can return to our last agenda items, the 2024 budget.

DISCUSSION ONLY

MOTION: DRESEL REOPEN 2024 BUDGET AGENDA ITEM

SECOND: CHARTAND

MOTION PASSED UNANIMOUSLY

1. 2024 Police Commission Budget - continued

Commissioner Chartrand advised she had a couple questions. One, I assume you guys are union, and there is a step and that we have no control over that, you advance from step one, to step two, to three, is that correct?

Chief Schlumbohm replied, that is correct.

Commissioner Charrtrand asked: The full time employees I see jumping 21 to 22 7%, 22 to 23 jumping about 10 percent, is that adding any head count or is that simply what we had negotiated as part of our 5 step?

Chief Schlumbohm replied, No, there is no adding or change in personnel it just strictly falls under their contract.

Commissioner Chartrand asked, And then we negotiate every five years, or every.... Is that how it is handled?

Chief Schlumbohm responded, That can vary. I believe our last one was three years.

Administrator Pechman also replied, Just so you guys know, over the years of negotiating, we've really settled in on our comparable cities, so we've not budged on that, and it's worked fairly well. We've always said we won't be the highest, and we won't be the lowest, we're always shooting towards the middle. So, we don't want to be raising the bar, and we don't want to be below it either. I can tell you from where Dan's coming from, we're getting out butts kicked.

Commissioner Chartrand said, Yeah, we're low.

Administrator Pechman said, But just so you know how we get there, we already have established comparable cities, and there's really not a ton of discussion about it, we know we've got to be competitive with these cities, and now it's gotten to the point it just....They're throwing money at....Who's going to throw the most money out to get police officers. You have cities officer to put CSOs through two years of school.....for free. That's what we're up against.

While negotiating, the union suggested, and it was accepted, that there is a clause in there that if you want to decided that your officers should get more, you don't need to come back and negotiate that, whatever you add is fine. Because of the current lack of officers.

Commissioner Chartrand stated, so I think that is something we want to pay attention to, because we've got good....we've got great people, and we've got good retention. So I just thing we want to know when this hits for a redo, we might end up getting hit. This goes back to that money issue here. You do a fantastic job, and there are many things that generate retention. It starts with, they like their leader. Good facilities are relevant, we maybe don't hit high on that one. Overtime pay is high, training, those are all things that factor in. Year, I know the numbers are pretty crazy right now in major cities for police officers. I just wanted to bring it up and know that if things keep going the way they are, we might have some more expenses that we might have to pay.

Chief Schlumbohm responded, You're a 100% right. Right now, we're not at the 50 percentile, we're below. But, the Officer that work here, care about Chisago, they care about Lindstrom, and they take it very very personally. I've Officers offered 5-10 dollars an hour more. I even had one say, Yeah, I need to take this other job for my family, and then withdrew, and said Nope. I'm not leaving here. I like where I work, I like the people I work with, the people who support me. I like working here. Honestly, he was going to go to North Branch, where he would make substantially more. But he backed out, and said I'm sorry, I'm staying. Part of that is they know that the people here support them, and they try and do the best that they can, and we try and do the best we can with what we have. So, it goes both ways, they appreciate it. Like we always said in K9 school, confidence flows down the leash. If we're confident in them, they're confident in what they do. That's makes them calmer, and situations deescalate, and it just makes everything work better.

Commissioner Chartrand said, So that was....I really just wanted to tune in on the people resources in the budget. That's all. Otherwise, it looks like a pretty conservative budget. You do a good job Bill.

Chief Schlumbohm responded, No, Cassie does a good job.

Commissioner Chartrand replied, You do a good job Cassie! You keep saving that money!

Commissioner Dresel stated, You know, I will say, being on this for a while, budgets come in pretty even. We haven't had any major increases, we've always done a responsible job of paying for equipment and trucks, and cars, and it's just been a steady Eddie of going through. I always joke that this is the best

commission to be one, because we are always getting awards, we're always having celebrations, we have the best police department in the area.

Commissioner Norelius stated, Did we want to add any budget for improvements?

Commissioner Dresel said, Yeah, back to the lobbyist, I really want to keep it in, with all this discussion, I think is great. I want to just keep pushing on you guys to keep moving forward. I know that a lot of these issues we've talked about, let just get through them. I know that having Dan on board will help you guys get through it. But we'll be here, we've been partners for a long long time, and we want to be partners for a very long time, so... We've all been through this, so sometimes it gets a little frustrating, we've been through it. We want to get it moving, and we're at a really good point. With that I do think we should keep supporting the lobbyist, it seems to make some good traction. I know it's been 20, I think we should go up a little larger, you know maybe go to 40. You know, to Dan's point, maybe we should do consulting. Maybe increase the budget a little bit and start prepping for some maintenance of the building. I wouldn't mind seeing maybe 40 added to the future building.

Commissioner Chartrand stated, We can reallocate it as needed, correct? So if we did need to retrofit and move the file cabinets and whatever, we could allocate it that way.

Commissioner Dresel stated, I think we can do whatever we want with the money. We can always reallocate it out of the budget I would think.

MOTION: DRESEL TO APPROVE THE 2024 BUDGET AND ADD 40,000 TO THE LOBBYIST LINE ITEM

SECOND: CHARTRAND

Dresel said, Just one thing too.. We can go back to the lobbyist whether we do it or not, it gives us a little bit of money for analysis or anything else we need to do, and gives us a little bit of money for next year if we want to do a wall, a door, or something. It helps it a little bit.

CORRESPONANCE

Bi-Monthly Police Activity Report Annual Department Report

Chair Gustafson commented that he really enjoys the crime report, and it was quite large this time.

Chief Schlumbohm advised that they were quite busy, and most recently had an armed robbery at the boat access in Lindstrom that took quite a bit of investigative follow, and the previous night Nick and Drews had a fire inside.

Commissioner Norelius asked if there were any particular trends surrounding crime recently. Chief Schlumbohm advised the common denominator lately was the involvement of juveniles and young adults during the summer months. Vandalism and parks generate a lot of time in follow up, along with public nuisance and zoning violations. Zoning and ordinance violations now have a dedicated officer, which has been working very well over the past few months.

Commissioner Norelius stated, I brought that up last time, what are we doing to charge back these landlords of problem properties for these calls, the extra calls? I think it's the only way to actually get action. They need to start charging them \$150 a pop for these calls.

Commission Chair Gustafson said, that's something that your city would do. That's a city rule.

Chief Schlumbohm advised, that is a fine from the city. But you'll need to talk to your city attorney about it, they are difficult to do. It's easy to pass the ordinance to do that, but difficult to actually do. Many cities put out fines, but people don't pay them. Just like not mowing your grass. If you don't, we'll mow it and charge you. Well, I won't pay. Fine, then we'll put it on your taxes. Just like not paying your water bill. It just sits there. Our take on it, is that we will charge you in criminal court as the land owner. A lot of people may not care about the \$150, but they don't want to go to Center City to go to court. But for the fine side, I would definitely talk with your city attorney.

Commissioner Chartrand asked to pass on to the Officers that they did a great job at Karl Oskar Days, they were friendly, they blended in, they did a great job with traffic control, and they kept order.

Thank you for the opportunity to present a proposal to represent the Lakes Area Police Department (LAPD) for legislative representation during the interim and for the 2024 Legislative Session. Working with LAPD is a perfect fit with my background and experience on capital investment issues and being a long time Chisago County resident and business owner. This proposal builds on the work we've done for the LAPD to lay the groundwork for the Lakes Area Law Enforcement Center.

Conservation Strategies would assist the Lakes Area Police Commission with the bonding project and legislative development and strategies. These strategies would include: navigating the legislative process from beginning to end, facilitating and building relationships with appropriate stakeholders, developing communication strategy, monitor relevant committees and legislation, and provide updates to the Police Commission Board.

The 2023 Legislative session saw a bonding and cash bill for infrastructure totaling \$2.8 billion dollars; out of over \$6 billion in requests. As a part of the negotiations for the 2023 bonding bill, there was agreement to have a \$880 million bonding bill and a \$828 million cash bill. In addition, the Chisago Lakes area was successful in securing their top priority of funding for Highway 8, this moves the LAPD Law Enforcement Center to a high regional priority for local legislators.

This proposal is to assist the Lakes Area Police Commission Law Enforcement Center bonding project for 2024 legislative session, building upon the work of the 2022 and 2023 Legislative Sessions.

Specifically, Conservation Strategies would:

- Serve as the point person for the LAPD with Rep. Neu-Brindley and Sen. Koran.
- Develop legislative and communications strategy for the LAPD.
- Draft bills, secure bill introductions, coordinate hearings and testimony.
- Assist with developing fact sheets, handouts, talking points and key messages.
- Advocate with the Governor's office, House and Senate Capital Investment Committee members, and other key policy makers.
- Monitor Governor's 2024 local government bonding process.
- Monitor 2024 House, Senate Capital Investment Committee hearings, House, Senate bonding bills, floor action and conference committees.
- Prepare regular legislative updates and end of session report.

Terms:

November 1, 2023-December 31, 2023. \$1,000 per month for a total of \$2,000. Begin implementation of legislative strategy, communication strategy and materials, begin to schedule meetings and facilitate relationships with key legislators and stakeholders.

January 1 – June 30, 2024. \$4,000 per month for a total of \$24,000 payable in monthly installments as billed. For a total of contract: \$26,000.

BACKGROUND:

JUSTIFICATION:

Many of the questions involve the physical construction of the facility, as well as its efficiency and mechanicals.. They stated that they have perform similar services for other communities during their planning phase, and provided a proposal to develop proposed costs and construction options for the Commission's review.

FINANCIAL IMPACT:

The proposal includes reviewing existing studies and information, interviewing key staff and administration, creating master budgets, and attending police commission meeting for presentation and feedback. They would also assist in the creation of public information using mailings and/or social media. The proposal is for \$10,000 and would be fully reimbursed if Kraus-Anderson continues into the construction phase.
