**AN ORDINANCE AMENDING CHAPTER 30 OF THE LINDSTROM CITY CODE
CONCERNING CITY COUNCIL MEETINGS**

THE CITY COUNCIL OF LINDSTROM ORDAINS:

SECTION 1. Lindstrom City Code Chapter 30, Section 30.01 (A) is hereby amended by adding the underlined language and deleting the ~~striketrough~~ language as follows:

(A) Regular meetings of the Council shall be held on the third ~~Thursday~~Wednesday of each calendar month at 7:00 p.m. Any regular meeting falling upon a holiday shall be held on the next following business day at the same time and place. All meetings, including special and adjourned meetings, shall be held in the City Hall unless the Council decides otherwise at a prior meeting or meeting in the City Hall is impossible.

SECTION 2. Lindstrom City Code Chapter 30, Section 30.04 is hereby repealed in its entirety.

SECTION 3. This ordinance shall be effective immediately upon its passage and publication.


